Seafood Compensation Plan Sworn Written Statement for Designation of Ownership Percentage of Jointly-Owned or Leased Seafood-Harvesting Vessels, Oyster Leaseholds, and Individual Fishing Quotas

This Sworn Written Statement ("SWS-25") allows claimants who owned or leased a Seafood-harvesting vessel, oyster leasehold, or Individual Fishing Quota ("IFQ") jointly with another individual or business to indicate in what percentage they owned or leased the claimed vessel, leasehold, or IFQ.
